 every ꝑte & ꝑcell thereof doth acquit Exonerate & discharge th^e s^d
 Wahop his heirs Execu^{tr} & Admīs^{trs} Hath bargained sold aliened
 assigned set over & confirmed & by these ꝑ^rsents doth bargaine sell
 aliene & confirme unto th^e s^d Wahop 400 Acres of land being ꝑte
 of a Devident of 500 acres sold to th^e s^d King by Tho: Stone &
 John Stone & first taken up by M^r Ja: Lendsy & by him sold to
 Jeremiah Dickinson & afterwards bought of the s^d Jeremiah by Rich:
