And where upon th^e ſd Nicholas Complaineth ag^t th^e ſd Rich: Boughton, th^t is to ſay th^t whereas th^e ſd Nichol: in th^e month of March in th^e three & thirtieth yeare of th^e Dominion of Caecilius &c, at th^e Inſtance & request of him th^e ſd Rich: & at divers & ſundry oth^r times ſince hath ſold & ſd^d unto th^e ſd Rich^d diſverſe parcellſ of Drink, & oth^r ordinary Accomoda^ons & neceſſarys am^ging to in th^e whole to 2703^{lb} Tobacco w^{ch} ſd ſum^e of 2703^{lb} of Tobacco th^e ſd Rich: did Assume upon himſelf & to th^e ſd Nicho: did faithfull p^mise th^t he th^e ſd Rich^d th^e aboveſd Quantity of 2703^{lb} Tobacco well & truly would ſatisfy & pay unto th^e ſd Nicho: wⁿ there unto required, Notwithſtanding th^e ſd Rich^d though often thereunto requeſted hath not ſatisfied nor any wiſe Contented th^e ſd Nicho: for th^e ſame but altogether refuseth to ſatisfie th^e ſame where upon th^e ſd Nicho: ſaith he is Damnified & hath loſſe to th^e valew of 3000^{lb} Tobacco & thereupon he bringeth his ſuite.
