Whereupon the plt produced an acct for the sd tobacco & the Deft alleaged tht he had an acct of Ctks Fees due from the plt to him web he pray'd might be allowed in discount wth the Plt but the Defts acct not being ready to be produced in Court It was ordered tht Mr Benja: Rozer should before tob: time audite the Accts of the plt & Deft & tht wtever appeared upon the Audite & report thereof to be due from the Deft to the plt upon the ballance of theire accts tht the Deft should satisfy the same to the plt or else Execution.
