This Indent^r made th^e 15th of Aug^t in th^e yeare of our Lord 1669 Betweene Alex: Davies of Charls County plant^r of th^e one part & W^m Love of th^e same County plant^r of th^e other parte Witnesseth th^t th^e sd Alex: Davies for & in Considera^on of th^e quantity of 3900th of To^b: & Cask in hand pd before th^e ensealeing & delivery herof by th^e sd W^m Love whereof & wherewth th^e sd Davies doth acknowledge himself satisfied Contented & pd & of every parte & parcell thereof doth acquitt & discharge th^e sd Love his heirs Exec^{trs} & Administra^{trs} & every of them by these p^rsnts Hath given granted bargain'd sold ass^gnd set over & Confirmed & by these p^rsnts doth bargaine sell assigne set over & Confirme unto th^e sd Love his heirs Exec^{trs} Ad- ministra^{trs} & Ass^gs all th^t parcell of Land lying scituate & being in Charles County being part of th^e land formerly taken up by M^r James Lendsey but now in th^e Occupation of Thom: King plant^r beginning at a mark'd Birch tree being th^e eastermost bound tree of Cap^t W^m Stones Land called Poynton standing on th^e east side of a fresh runn & ruⁿing thence North & by west for bredth sixty four perchs to a bounded white Oake thence west North West for length two hundred & fifty perchs to a bouned spanish Oake thence south sixty four perches to a bounded red Oake thence untill it Come to th^e 1st bound tree Containing & now laid out for one hundred Acres more or less together wth all and singular th^e houses buildings structures or edifices & all orchards Gardens pastures Feedings Co^mons Co^mons of pastures range for hoggs woods underwoods water water Courses fishings fowlings wayes easm^{ts} proffitts Co^modities or hereditam^{ts} to th^e sd land belonging or in any manner of way appertaineing To have & to hold th^e sd parcell of Land & all & singular th^e p^rmises
