This Indenture made th^e ninth of 9^{br} in th^e yeare of ou^r Lord 1669 Between Tho: King of Charls County in th^e Province of Maryland pl^{tr} of th^e one part & Alex: Davies of th^e afore^sd County pl^{tr} on th^e other part Witnesseth th^t th^e s^d Thomas King as well for as in Considera^on of 4000th of to^b & Cask to him in hand pd by th^e s^d Davis th^e receipt whereof th^e s^d King doth hereby acknowledge & himself to be therewth fully satisfied Contented & p^d & thereof & therefrom & of & from every part & parcell thereof doth acquitt & discharge th^e s^d Davies his heirs Exec^{tr}s Admi^{tr}s by these p^rsnts Hath bargained sold aliened enfeoffed ass^g'd & set over & by these p^rsnts doth fully & clearly bargaine sell Aliene enfeoff & Confirme unto th^e s^d Davies his heirs & Ass^gs for ever all th^t parcell & tract of land situate lying & being up th^e Eastermost branch of Avon river formerly called Nonjemy Creek begiⁿing at a birtch tree being th^e eastermost bound *tree* of Cap^t W^m Stones land called Pointon (*) standing on th^e east side of a fresh runn runing *thence* N & by W for breadth 64 perches to a bounded white oake thence W: N: W: for *length* 250 perches to a bounded spanish Oake thence S; 64 perches to a bounded red *oak and* thence untill it come to th^e first bound tree containeing & fd out for 100 Acres *more or less* it being parte of th^e land taken up p^r M^r James Lendsy but now in th^e possession of *Thomas King* wth & singular th^e houses Edifices buildings orchards pastures meadows Feedings waies water *water courses* yards backsides Easem^{ts} p^rfitts Co^modites & Appurtenances to th^e s^d p^rmises or any part *or parcell* thereof belonging or in any wise appertaineing & also all th^e rights estate title *interest use* p^rpty possession reversion clame & demand of him th^e s^d King of & in th^e same, To have *and to hold* th^e fore^sd parcell of land & all & singular other th^e p^rmises before granted bargain'd & sold wth *their and every* of their rights members & Appurtenances w^{so}ever unto th^e s^d Davies his heirs & ass^gs for *ever* & th^e s^d King doth for himself
