Edward Maddock p^{ft} came & made his appearance at this Court to prosecute his Suite against Richard Boughton in an a^{co}n of debt whereupon the p^{ft} presenteth this Ensueing declaracon to be read in Court as foll: vjz:

Charles County ss: Ed: Madock p^{ft}: Rich: Boughton Deft

The p^{ft} Complaineth against the defendant for that the def^t Standeth indebted unto him th^e Said p^{ft} by bill under his hand & Seale bearing date th^e 27th of August 1668 in th^e 38th yeare of the Dominion of Caecilius &c: by w^{ch} bill he the S^d Def^t did assume & to th^e Said p^{ft} did faithfully promise the Sume of four hundred pounds of Tobaccoe to him the S^d P^{ft} he would when thereunto required well & truly pay yet nevertheles the S^d Deft his S^d promise & assumption little minding or regarding the Said Sume of foure hundred pounds of Tobaccoe to him the S^d p^{ft} hath not payd although thereto often required whereby th^e S^d p^{ft} Saith he is damnified & hath loss to the vallew of 700th of Tobaccoe & thereupon he bringeth his Suite

whereupon the Said p^{ft} produced the defts Bill as above S^d & the deft not being able to Shew any lawfull reason to the Contrary the Court passed Judgem^t against the deft for the Sume of 400th of Tobacco as aforesaid with Costs of Suite &c & the p^{ft} preferred his Bill of Costs as foll:
