

Liber D 1668 in th^e xxxviith yeare of the Dominion of Caecilius &c had & received from th^e Said Edmond divers parcells & quantitys of Drinke & other ordinary accomodacons a particular acco^t whereof is here in Court by the Said Edmond produced amounting to the Sum^e of foure hundred ninety Eight pounds of tobaccoe the Said william did in Considera^on thereof then assume on himselfe & to the Said Edmond did faithfully promise th^t he th^e s^d Will^m the S^d Sum^e of 498th of tobaccoe to the Said Edmond when thereunto required would well & truly Satisfy & pay Notwithstanding the Said william his promise & assumption little minding or regarding but devising & fraudulently intending him the Said Edmond the Said Sum^e of 498th Tobaccoe to deceive the Said Sum^e of 498th of tobaccoe to him the Said Edmond hath not Satisfyed but Doth altogether refuse to pay the Same whereupon the Said Edmond Saith he is damnified & hath Loss to the vallew of 800th of tobaccoe & thereupon he bringeth his Suite &c, And withall the p^lt produced a particular acco^t of the Severall goods before men^oned which the deft putting him to the prooffe of.

Ralph Coates Subp^a in the behalfe of th^e p^lt Sworne & Examined Saith that he with his owne hands delivered severall parcells of drinke & other goods to the d^eft as is abovespecified

Whereupon the Def^t alleaging that the p^lt had Killed a steere of his th^e S^d Def^{ts} & had not given him any acco^t thereof whereupon th^e p^lt Compounded with the S^d D^eft to allow him the S^d Def^t for the Said Steere the Sum^e of 325th of Tobaccoe & the Def^t Confesseth a Judgem^t for 173th of tobaccoe being the rem^a of the Said 498th of tobaccoe & the p^lt requesting it was allowed Sixty pounds of tobaccoe for his two days attendance on the Court.

Rich: Fowkes being Attached to answer to Edmond Lendsey in a plea of trespasse upon the Case for the Sum^e of One hundred twenty Eight pounds of tobaccoe the acco^t having been first proved by the oathes of Edmond Lendsey & Ralph Coates by his Attorney Confesseth Judgement for the Said Sum^e of 128th of Tobacco wth Costs of Suite the p^lt was allowed ninety pounds of tobacco for his owne & Evidences charges

Richard Boughton being Attached to answer to the Said Edmond Lendsey In a plea of trespasse upon the Case for the Sum^e of One thousand Six hundred forty & two pounds of Tobaccoe Confesseth a Judgem^t to the Said Edmond Lendsey for the Said sum^e of 1642th tobaccoe with Costs of Suite.

Jacob Leak being Attached to answer to the S^d Edmond Lendsey in an ac^on of trespasse upon the Case amounting to the Sum^e of Seventy Eight pounds of tobaccoe the acco^t being first proved by the oathes of the Said Edmond Lendsey & Ralph Coates Confesseth a
