Liber D whereupon the pits declaracon was read in Court to the Effect as folt.

The Said Edmond complaineth against the Said Henry for that whereas the Said Henry the 5th day of october in yeare 1668 in the xxxviith yeare of the Dominion of Caecilius &c had & received of the Said Edmond divers parcells & quantities of drinke and ordinary accomodations amounting to the Sume of Seaven hundred pounds of Tobaccoe a particular accot whereof is here in Court by the Said Edmond produced In Consideracon whereof the Said Henry did then assume on himselfe and to the Sd Edmond did faithfully promise that he the Said Henry the Said Sume of 700th of tobaccoe to him the Said Edmond would when thereunto required well & truly Satisfy & pay Notwithstanding the Said Henry his Said promise & assumption little minding or regarding the Said Sume of 700th of Tobacco to him the Said Edmond hath not Satisfied but doth altogether refuse to Satisfy the Same to the great damage of him the Said Edmond who Saith he is Damnified & hath loss to the vallew of 1200th of Tobacco and thereupon he Bringeth his Suite.

And therewith the S^d Edmond preferred his acco^t of particulars amounting to the Sume of Seaven hundred pounds of Tobaccoe as is before Specified, Whereupon the def^t not being able to Shew any Just Cause to the Contrary the Court passed judgement against the Defend^t for the Said Sume of Seaven hundred pounds of Tobaccoe with Costs of Suite.

And the plt requesting it was allowed 90th of Tobaccoe for his owne charge & attendance.

Edmond lendsey plt Came & appeared to prosecute the Suite by him comenced against John Thomkinson for the Sume of three hundred twenty Seaven pounds of Tobaccoe.

John Thompkinson Defendant Came likewise & appeared to answer & defend the Suite Comenced against him by Edmond Lendsey as aforesaid

The Said Edmond Complaineth against the Said John for that whereas the Said John the 10th day of november in the yeare of our Lord 1668 in the xxxviith year of the Dominion of Caecilius &c, had & recd of the Said Edmond Divers parcells & quantitys of Drink & other ordinary accomodacons amounting to the Sume of three hundred twenty Seaven pounds of Tobaccoe In Consideracon whereof the Sd John did then assume on himselfe and to the Said Edmond did faithfully promise that he the Said John the Said Sume of 327th of Tobaccoe to him the Said Edmond would when thereunto required well & truly Satisfy & pay Notwithstanding the Said John his Said promise & assumption little minding or regarding the Said Sume of three hundred twenty Seven pounds of tobaccoe to him the Said Edmond although often thereto required hath not payd but doth altogether refuse to pay the Same to the Great damage of him the Said Edmond who Saith he is damnified & hath loss to the vallew of
