Edw^d Maddock Def^t likewise appeared to answer to th^e suite Comenced ag^t him by Edm^d Lyndsy whereupon th^e sd pl^{ts} Declaracon was read to this effect

The sd Edm^d Complaineth ag^t th^e sd Edward for th^t whereas th^e sd Edward th^e fifteenth day of Aug^t in th^e yeare 1668 & in th^e xxxvii yeare of th^e Dominion of Caecilius had & rec^d of th^e sd Edm^d divers parcells of Drink & ordinary Accomodacons from th^e sd fifteenth day of Aug^t & In th^e yeare aforese^d & att divers dais & times till th^e eleventh day of february 1668 a particular Acc^t whereof is here in Court by th^e sd Edm^d produced amounting to th^e Valew of one thousand one hundred & three pounds of to^b & being soe indebted as aforese^d th^e sd Edw^d in Consideracon thereof did then Assume upon himself & to th^e sd Edm^d did faithfully promise th^t he th^e sd Edw^d th^e sd sume of 1103th of to^b to th^e sd Edm^d wⁿ thereunto required would well & truly satisfy & pay notwithstanding th^e sd Edward his pmise & assumption little regarding but deviseing & fraudulently intending him th^e sd Edm^d of th^e sd sume of 1103th of to^b to deceive th^e sd sume of 1103 of to^b to him th^e sd Edm^d hath not satisfied according to his promise to him on th^t behalfe made But doth altogether refuse to pay th^e same to his [p. 128] th^e sd Edm^{ds} great damag whereupon he saith he is Damnified & hath loss to th^e valew of 1800th of to^b & thereupon he bringeth his suite.

Whereupon th^e sd Edm^d produced his acc^t & th^e sd Def^t haveing nothing to say why Judgm^t should not pass.
