And whereupon th^e s^d Edw^d Complaineth ag^t th^e s^d Edm^d for th^t whereas th^e s^d Em^d on th^e tenth day of Aug: in th^e xxxvii yeare of th^e Dominion of Caecilius 1668 at divers daies & times since had & rec^d from th^e s^d Edw^d divers parcells & quantities of medicines & Visits & Attendance am^ting to nine hundred & eighty pounds of to^b by a p^ticular Acc^t thereof here in Court exhibited more plainely may appear in Considera^on whereof th^e s^d Edm^d did then Assume upon himself & to th^e s^d Edw^d did faithfully promise th^t he th^e s^d Edm^d th^e s^d sume of 980th of to^b to him th^e s^d Edw^d wⁿ thereunto required would well & truly satisfy yet never th^e less th^e s^d Edm^d his s^d p^mise & Assump^on little regarding but minding & fraudulently intending him th^e s^d Edw^d of th^e s^d sume of 980th of to^b to deceive th^e s^d sume of 980th to him th^e s^d Edw^d hath not p^d but doth altogether refuse to satisfy th^e same to his th^e s^d Edw^{ds} great Damage whereupon he saith he is Damnified to th^e Valew of 1200th of to^b and hereupon he bringeth his suite.
