 other part Witnesseth, That the sayd Ignatius Causine for and in th^e
 consideracon of th^e Sūme of [blank] thousand [blank] hundred
 pounds of To^b to him in hand payd at & before the Sealeing and
 delivery of these p^rsents by the s^d John Hackister th^e receipt whereof
 th^e s^d Ignatius doth hereby acknowledge & himselfe fully Satisfyed
 and payd & thereof & of every part and parcell thereof doth clearly
 acquitt exonerate and discharge th^e s^d John Hackister his heyres
 Execut^{rs} & Administrators forever by these p^rsents Hath given
 granted aliened bargained Sold enfeofeed & confirmd And by these
 p^rsents doth fully clearly and absolutely give grant bargain aleien
 sell enfeofee and confirm unto John Hackister his heyres and As-
 signes forever all th^t parcell of land lyeing in Charles County
