

a marked Oke in the woods by th^e head of a swamp bounding on the South by a lyne drawne west for breath fifty pches to a marked Peckickory tree by a hill side on the west by a lyne North, from the Peckickory, for lenth three hundred & twenty pches to an Oke by a runn side In a swamp on the North by a lyne drawne East from the s^d Oke for breath fifty pches to a marked Pickickory by a swamp on the East by a lyne drawne by a lyne drawne south from th^e s^d Pickikory unto the first marked Oke, containeing and layde out for one hundred acres be the same more or less The other parcell Called Johnsons retyrem^t begining at a marked Pickikory being th^e bound tree of Danyell Mount and runing south for the length of thyrty pches to a bounded locust & from the sayd locust runing East for the length of nynety pches to a marked Oke standing in th^e mayne Swamp of Sacaio bounding on the East by a lyne drawne north from the sayd Oke, to a bounded Oke being th^e first bound tree, of Daniells Mount aforesayde continueing the sayd North lyne from the sayd Oke for length two hundred & twenty pches to a bounded Oke on the North by a lyne East from the end of the former lyne for the length fifty pches, to a bounded Gumm on the East by a lyne drawne South from the End of the sayd East lyne, two hundred & eighty pches to a bounded Oke th^t intersects a paralell lyne drawne west to the bounded Oke, standing in Sacaio Swamp, on the South and the west wth th^e sayd North lyne, contayneing and layd out for one hundred acres more or lesse, Now in th^e Tenor & occupaçon of him the s^d Sam: Fendall his heyres or Assignes, all and singuler the s^d parcells of land together wth all and singuler the houses buildings Structures and Edifices thereunto belonging or apptayning together wth all th^e Gardens pastures Orchardes feedings Comõns of pastures ranges for hoggs woods underwoods water courses fishings fowleings Easem^{ts} pfitts comodetyes & hereditam^{ts} w^tsoever unto th^e s^d parcell of land belonging or in any manner of way apptayneing, To Have & to hold, the s^d parcell of Land and all and singuler th^e afore menõned p^rmisses to be hereby bargayned and Sold, wth th^e appurtenances and every part and parcell thereof w^tsoever before named or recited unto the s^d William Barton his heyres Execut^{rs} & Administ^{rs} forever, and the s^d Sam: Fendall for himselfe his heyres Execut^{rs} & Administrat^{rs} doe covenant grant and agree to and wth th^e s^d William Barton his heyres Execut^{rs} Administrat^{rs} and Assignes & every of them by these p^rsents, That he the s^d William Barton his heyres Execut^{rs} Administrat^{rs} and Assignes shall and may quyetyly & lawfully peaceably have hold occupye possess & Enjoy all and singuler the p^rmisses before by these p^rsents bargained and Sold, And every part and parcell thereof, wth every th^e Rights members and Appurtenances, wthout the lawfull lett sute trouble Evicõn expulcõn Inturruptõn or demand, of or by th^e s^d Fendall or of or by his heyres Execut^{rs} Administrat^{rs} or any or either of th^m or by
