Whereupon the p̄t Complaineth ag^t the Deft for that whereas the Deft Stands indebted unto him th^e Said plt in th^e Just quantity of one thousand Six hundred and fifty pounds of tobaccoe & Caske as P̄ his Bill under his hand & Seale bearing date the 18th day of february 1669 will more plainly appeare now the Said Thomas the Said Sumē of 1650th tobaccoe & Caske Refusing & denying to pay being often thereunto Required but intending fraudulently & Craftily to Cozin & deceive the Said william of th^e Said quantity of 1650th tobaccoe & Caske he therfore bringeth his Suite, praying yo^r wo^rps Judgem^t therefore, wth Cost of Suite.

And for prooffe of this his declaracon he produced this Ensueing bill.
