Edmond Lendsey aged Sixty foure yeares or thereabouts Sworne Saith That Sometime in Aprill Anno Domini 1668 Dan: Johnson upon th^e Calving of Two Cowes by him dellivered to Jeremy Canedagh th^e S^d Jeremy told him th^t they had brought bull Calves w^{ch} Daniel Johnson ordered him th^e S^d Edmond to marke of his th^e Said Daniels marke & Cutt them & he would give Jeremy Canedagh two Cow Calves of the Same age in the roome of them & further Saith not.

whereupon the Court gave Judgem^t ag^t the Def^{ts} for two Cow Calves which were Calved Sometime in march or Aprill Last with Costs &c

In a Certain matter of Difference depending between George Godfrey p^{ft} & Francis Kilborne & Eliz^a his wife Adm^{rx} of th^e Goods & Chattells of Dañ: Johnson Deçd Def^{ts}

The p^{ft} preferreth this Ensueing declaracion to be read in open Court as folt:

And whereupon th^e S^d p^t Complaineth agst the def^{ts} for that whereas he the Said George did Sometime about the first day of May in the 38th yeare of the Dominion of Caecilius &c Annoçq Domini 1669, & att divers days & times Since till the last day of June in th^e Same yeare at the Speciall instance & request of Daniel Johnson doe Severall parcellls of building & other worke amounting to the Sum^e of one thousand Six hundred pounds of Tobaccoe as by a particular acco^t here in Court produced more plainly may appeare In Consideration whereof the Said Daniel did then assume & to the Said George did faithfully promise that he the Said Daniel the S^d Sum^e of 1500th tobaccoe when thereunto required would well & truly Satisfy & pay Yet nevertheles the Said Daniel in his lifetime nor the S^d Francis & Eliz^a his wife Since his death the Said Sum^e of 1500th tobaccoe although often thereunto required have not Satisfyed but do altogeth^r refuse to pay th^e Same whereupon th^e S^d p^{ft} Saith he is damnified & hath loss to the vallew of 2400 of tobaccoe & thereupon he bringeth his Suite
