This Indenture made th^e nynth day of October Annoq³ Dñi 1672 Betweene Joseph Harrison of Charles County in the Province of Maryland Gen^t of th^e one part and Luke Greene of the Same County Planter of th^e other part, Witnesseth th^t th^e said Joseph Harrison as well for & in considera^on of a certaine lease of a parcell of land w^{ch} he th^e said Luke Greene formerly bought of the said Joseph Harrison w^{ch} said land th^e Said Joseph Harrison hath allready received into his possession wherewth he doth acknowledge himselfe to be fully Satisfied contented and payd, as allsoe for divers other good causes him thereunto moveing Hath Bargained Sold aliened assigned enfeofeed and sett over, And by these p^rsents doeth fully clearly and absolutely Bargaine Sell alien assigne enfeofee and Sett over unto th^e said Luke Greene his heyres and assignes forever all th^t parcell of Land called Greens purchase Scituate lyeing and being on the east side of the Anocostine River in the County aforesaid & on the South east side of a Branch or a Creek in the said River Called Isedores Creeke being butted and bounded as p^r Pattent rela^on being thereunto had may more at large appeare containeing two hundred Hundred acres more or less, wth all and Singular the pastures feedings wayes water Courses woods underwoods p^rfits com^odetyes & appurtenances to th^e Said p^rmisses or any part or parcell thereof [fol. 86] belonging or in any wise appertaineing and allsoe all th^e Estate Title Intrest use property possession claime and demand of him the said Joseph Harrison of in and to the same Together wth all Deeds writeings Manuscripts or papers touching or concerneing the same or any part or parcell thereof To Have & To Hold the said parcell of Land wth all and Singular the p^rmisses before granted bargained & Sold wth theyre and every of theyre Rights Members & appurtenances w^tsoever unto him th^e said Luke Greene his heyres and assignes forever, And the Said Joseph Harrison doth for himselfe his heyres Exec^{rs} and Adm^{rs} Covenant p^rmise grant & agree to and wth the Said Luke Greene his heyres Executors Adm^{rs} & assignes th^t th^e p^rmisses now are and forever hereafter Shall be and continue freely and clearly acquitted exonerated & discharged of and from all and Singular other former Bargaines Sales Gifts Grants leases Mortgages Joyntures Dowers Claymes demands & incumbrances w^tsoever by him them or any of them formerly had done or com^omitted or to be
