This Indenture made the Eight day of March Annoq̄ Domini 1672 Between Tho: Alanson of Charles County in th^e Province of Maryland of the one Party and John Lambert of th^e afores^d County & Province of th^e other Party Planter, Witnesseth th^t the s^d Tho: Allanson as well for and in consideration of th^e quantity of of three thousand poundes of Tobacco in caske to him in hand payd by the s^d John Lambert the receipt whereof the s^d Tho: Alanson doth hereby acknowledge and dischargd th^e s^d John Lambert his heires Execut^{rs} Administrat^{rs} and Assignes by these presents hath given granted bargained Aliened sold Enfeoffed and confirmed and by these presents doth give grante bargaine sell Alien Enfeoff & confirme unto him th^e s^d John Lambert his heyres & Assignes for Ever part of th^t parcell
