ing know yee that I the s^d George Banks for good causes and
valueable considera^ons him thereunto moveing have remised released
and ever quitt clamed and by these p^rsents for himselfe his heyres
Executors and Adm^{rs} or assignes doth fully absolutely & clearly
remise release and for ever quitt claime unto Humphry Jones of the
County & Province afore^sd in his full possession and Seizen and to
his heyres Executors Adm^{rs} or assignes forever all Such Right Title
& Intrest & demand w^{so}ever as he the s^d George Banks had or ought
to have of in or to all & every the messuage Tenem^t or one hundred
acres of Land in the County afore^sd or of or into all and every
part & parcell thereof by force and virtue of any Indenture or other
assureance thereof acknowledged or made by the s^d Humphry
Jones to me the s^d George Banks by any other wayes or meanes To
have and to hold all the s^d Messuage or Tenem^t unto the s^d Humphry
Jones his heyres or assignes & to the onely use & behoof of the s^d
Humphry Jones his heyres Executors and Adm^{rs} forever Soe that
neither th^e s^d George Banks nor his heyres Executors Adm^{rs} or
assignes nor any p^{son} or p^{sons} for him or them or in his or theyre
names or in the name right or Stead of any of them, Shall or will by
any way or meanes hereafter have claime challenge or demand any
estate right Title or Intrest of in or to the p^rmisses or any part
or parcell thereof, but from all & every accoⁿ Right Estate Title
Intrest or demand of in or to the p^rmisses or any part or parcell
thereof they & every of them Shall be utterly excluded and barrd
forever by these p^rsents & also the s^d George Banks & his heyres
Executors Adm^{rs} the s^d messuage Tenem^t Lands & other the p^rmisses
wth the appurtenances to the s^d Humphry Jones his heyres Executors
Adm^{rs} & assignes to his or theyre p^p use and uses in manner &
forme aforespecefied ag^t theyre heyres Executors Adm^{rs} & assignes
& every of them Shall warr^t & forever defend by these p^rsents in
witness whereof I have interchangeably put my hand and Seale this
28th day of May Anno^q 1673 George Banks (locus Sigilli)
