The ensueinge Conveyance was acknowleđ in Court by the above menčoned Edward Maddock and William Thomas for a Tract of Land called Thomas his chance cont̄ two hundred acres vizt

This Indenture made this eighteenth day of february in th^e 42^d yeare of the dominion of the Right Hon^{ble} Caecilius &c, over this Province, And in the yeare of o^r Lord 1673 Betweene William Thomas of Charles County in the same Province of the on pte, And Robert Ingolsby of the same County planter of the other pte, Witnesseth that the śd William Thomas as well for & in Consideračon of the quantity of Seaven thousand pounds of Tobacco in Cask in hande paide before the ensealeinge & deliᵛy hereof by the śd Robert Ingolsby, whereof & wherewth the śd William Thomas doth acknowl- edge himselfe satisfied contented & payde, & thereof & of eᵛy pte & pcell thereof doth acquitt exonerate & discharge the śd Robert Ingolsby his heires execut^{rs} adm^{rs} & eᵛy of them by theis pntes As also for divers other good causes & consideračons him hereunto moveinge Have graunted bargained & Sold assigned sett over & confirmed, And by these pntes doe fully clearely & absolutely grante bargain Sell assigne Sett over & confirme unto the śd Robert Ingolsby his heires execut^{rs} adm^{rs} & asś All that pcell of land Scytuate lyeinge & beinge in Charles County aforemenčond called Thomas his Chance begininge at a bounded black Oake in the woods run- ninge thence Easte One hundred & fifty pches to a bounded red oake thence North two hundred & fowerteene pches to a bounded Pekickary thence West one hundred & fifty pches to an Oake thence untill it comes to the first bound tree, conteyninge & now layd out
