

Liber E for and furnisht w̄th meat drinke lodging &c for the Space of twenty Monthes for w̄ch the s̄d Thomas did promise & take upon him Self to pay unto her the s̄d Bridgett two thousand pounds of tōb Notw̄thstanding the s̄d Thomas has not minded his s̄d promise & assump̄con Soe made as aforēsd but neglecting her the s̄d B̄rdgett the s̄d Sūme of two thousand p̄ds of tōb to pay & Satisfie though often thereunto required for w̄ch s̄d Sūme th^e s̄d Bridgett brings this her Suite, And the s̄d Thomas Lomax in prōp̄ p̄son Sayeth that the above s̄d Nehemiah Blackstone hath Satisfied eight hundred pounds of tōb unto the s̄d Bridgett Whereupon the Com^{rs} gave Judgem^t ag^t the Def^t for the Sūme of twelve hundred pounds of tōb wth Costs as followeth

In a case depending between Jn^o Wood Plaintiff & Edmond Taylor Def^t The Plaintiff declares ag^t the Def̄ for the Sūme of eight hundred and twenty pounds of tōb due by acc^t in Court produced; as followeth:

To 24 Gallons of quince drinke 400th tōb
 To 21 Gallons of quince drinke in September 420th tōb
— Sūm tō 820th tōb

Thomas Cooper Sworne in Court & declares th^t he heard Edmond Taylor acknowledge th^e receipt of the s̄d 45 Gallons of quince drinke whereupon the Com^{rs} ordred judgem̄t to be entred ag^t the Def̄ for th^e Sūme of 820 lb tōb w̄th Costs as followeth
