[p. 177] In a cause depending between Ric^{hd} Ambrose Plaintiff and Thomas Russell Def^t th^e Plaintiff by his Attorney Jn^o Jones complaines ag^t th^e Def^t For th^t the s^d Thomas Russell refuseth to give a reasonable ac^t of to^b r^ecd for th^e use of the Plaintiff of Sundry p^{sons}: ordred that th^e Def^t remaine in Sheriffs hands untill he give Sufficient Security for his appearence the next Court.

In a cause depending between Benj^a Rozer Plaintiff & Philip Lines Adm^r of all th^e goods & Chattells of James Lluellin late of Charles County de^{cd}, Def^t, the Plaintiff in his p^p p^{son} declares ag^t the Def^t for th^e Sum^e of two thousand poundes of to^b due p^a bill of the s^d James Lluellins & in Court p^{duced} & proved by John Jones & Philip Gibbon ordred that judg^mnt be entred ag^t th^e Estate of the s^d Lluellin for the s^d Sum^e of two thousand poundes of to^b:

Ric^{hd} Beck confesseth a judg^mnt to Joseph Peirce for the Sum^e of four hundred Seventy and three poundes of to^b: wth cost taxed at 120th to^b

In a cause depending between Joseph Peirce Plaintiff and Francis Kilborne Def^t th^e Plaintiff by his Attorney Jn^o Jones declares ag^st the Def^t for th^e Sum^e of thirteen hundred fifty and nine pounds of to^b due by bill beareing date 30th of May 1672: & the Def^t by his Attorney Samu^{el} Cressy comes and defends the Suite & craves a non Suite for th^t th^e declara^{on} and writt doe not agree w^{ch} the Def^t proved in Court whereupon its was ordred that a non Suite be entred ag^t the Plaintiff wth costs of Suite & Def^t p^{duced} this followeing Bill of cost w^{ch} was allowed by th^e Com^{rs}.
