Thereupon the Plaintife acknowledged a Judgment to th^e Defend^t for th^e s^d sume

Ordered therefore That th^e Plaintife satisfie to th^e Defend^t the said Sume of 430th of tobaccoe wth Caske.

M^{dm} That Elizabeth Hasellton ran away and absented her selfe from her Master Nicholas Emerson for th^e space of sixteen dayes

This Bill bindeth me George Bradshawe of Charls Countie in th^e Province of Maryland Planter me my heirs Execut^{rs} Admin^{rs} or Assignes to deliver or cause to be delivered unto John Wheeler of th^e same Countie Planter him his heires Execut^{rs} Admin^{rs} or assigns one Man Serv^t between sixteen yeares ould and thirty, this said Serv^t is to have his full time to Serve according to th^e Custome of th^e Countrey and to be delivered in Charles Countie between this
