Be it Enacted by the Right Honourable the Lord Proprietary by and with the Advice and Consent of his Lordships Governor and the Upper and Lower Houses of Assembly and the Authority of the same That an Act of Assembly of this Province entituled an Act for the Speedy Recovery of small Debts out of Court before one Justice of the Peace made at a Session of Assembly begun and held at the City of Annapolis the fourth day of October Seventeen hundred and Sixty three be and is hereby continued and shall remain and be in full fforce for and during the Term of Seven Years and to the End of the next Session of Assembly which shall happen after the End of the said Seven Years
