Demetrius Cartwright } Comaund was given unto the Sheriff of Tal-  
 ag<sup>t</sup> } bot County that he should take John Watkins  
 John Watkins } late of Talbot County otherwise Called John  
 Watkins of Patuxent River in the Province of Maryland Sawyer  
 so that he might have his body before the Justices of the Provincial  
 Co<sup>r</sup>t this p<sup>r</sup>sent Tenth Day of ffebruary to answe<sup>r</sup>e unto Demetrius  
 Cartwright in a plea that he Rend<sup>r</sup> unto him the su<sup>m</sup>e of 1262<sup>l</sup> Tob.  
 w<sup>ch</sup> to him he oweth & unjustly Deteineth

And whereupon the said Demetrius by Kenelm Chiseldyne his  
 Attorney saith that whereas the said John the fifth day of January  
 in the yeare of our Lord 1668 by his Certeine writing obligatory  
 sealed w<sup>th</sup> the seale of the said John & here in Court pduced whose  
 date is the same day & yeare abovewritten did acknowledge himself  
 to owe & be indebted to the said Demetrius of the same place abovesd  
 in the full & Just su<sup>m</sup>e of 1262<sup>l</sup> of good sound Marchantable leafe  
 Tobacco in Casque, according to act of Assembly to be pd upon  
 Demaund at some Convenient place in Patuxent River unto the sd  
 Demetrius Cartwright his heirs Executo<sup>rs</sup> Adm<sup>rs</sup> or Assignes & to  
 p. 162 w<sup>ch</sup> paym<sup>t</sup> well & truly to be made did binde himself his heires  
 Executo<sup>rs</sup> Adm<sup>rs</sup> firmly by those p<sup>r</sup>sents, Notw<sup>th</sup>standing w<sup>ch</sup> the  
 sd John the sd su<sup>m</sup>e of Twelve hundred sixty Two pounds of  
 Tobacco according to the Teno<sup>r</sup> of his said bill hath not payd  
 though often thereunto Required but the same to pay altogether  
 Denyes to the Damage of the sd Demetrius 2000<sup>l</sup> Tob. & thereupon  
 he bringeth his suite.

And now here at this day to wit the sd 10<sup>th</sup> day of ffebruary in the  
 42<sup>th</sup> yeare of the Dominion of Caecilius &c Annoq; Domini 1673  
 the sd Sheriff of Talbot County Returnes to the Court here that  
 the sd John Watkins is not to be found in his Baliwick, whereupon  
 this being the second non est Inventus Returned in this Case the
