Ratifying & by these p<sup>r</sup>nts confirming all & whatsoever my s<sup>d</sup> Attorney shall lawfully doe or cause to be done for & concerning the Receipt of y<sup>e</sup> premises by uertue of these p<sup>r</sup>nts.
