And whereupon the said Benony by John Rousby his Attorney saith That whereas the said Nicholas the tenth day of June in the yeare of our Lord One Thousand six hundred Seaventy foure by his certaine Bill Obligatory Sealed with the Seale of the said Nicholas here in Court brought whose date is the day & yeare aforesaid did binde himselfe his heyres Exec<sup>rs</sup> Ad<sup>rs</sup> & Assignes well & truely to pay or cause to be paid unto the said Benony Eaton his heyres or Assignes the full & just Sum<sup>e</sup> of One Thousand pounds of good sound M<sup>r</sup>chantable tobacco in Caske (according to Act of Assembly) to be paid att his the said Nicholas his owne Plantacõn in Tredhaven in the County aforesaid att or upon the tenth of October then next Ensueing the date of the said Bill Notwithstanding which the said Nicholas the said One Thousand pounds of tobacco according to the tenour of the said Bill to the said Benony though often thereunto required hath not paid, but the same to him to pay hitherto hath denyed & as yett doth deny & refuse to the damage of the said
