Liber N N said County of Talbot this ensueing yeare And also shall render unto his Lordpp & other his Lordpps Officers a true & faithfull & perfect account of all & singuler his Lordpps rents & all other ffees & dues that he shall be intrusted with by his said Lordpp or any his Lordpps Officers within this Province to receive & collect And also of all publick & County Levyes that he shall be entrusted to collect And his accounts to his Lordpp his heyres and Successors for his rents fines forfeitures & other dues belonging to his Lordpp As also his account of all ffees dues or Sumes of money or tobacco for Levyes or ffees due to any his Lordpps Officers within this Province shall passe & give accompt off by the twentieth day of March next ensueing the date thereof And in all other things as Sheriffe of the said County shall behave himselfe well & honestly towards all persons according to the best of his power skill & knowledge Then this Obligacon to be Void & of none effect Or else to stand remaine & be in full force & Vertue-which being read & heard the said Vincent Lowe by his Attorney aforesaid prayeth liberty to imparle hereunto untill next Provinciall Court & itt is granted unto him the same day is given to the plaintiffe also

Now here att this day to witt the fourteenth day of March in the fourth yeare of the Dominion of Charles Lord Baltemore &c Annog Doni 1678 cometh as well the said Kenelm Cheseldyn Attorney Gen¹¹ as the said Vincent Lowe by his Attorney aforesaid, and the said Vincent saith nothing in barr of the action of the aforesaid Kenelm, by which the said Kenelm Attorney Gen¹¹ as aforesaid remaineth against the said Vincent thereof undefended Therefore p. 784 itt is considered that the Said Lord Prop^{ry} recover against the said Vincent Lowe the aforesaid Sume of two hundred thousand pounds of tobacco debt And the defendt in mercy &c

Upon the peticon of Elizabeth Smith, that sicknes hath rendred her unable to labour for her livelyhood, And that she hath no setled place to abide in, but what the charity of good people doth releive her withall, & humbly beggd an order of this Court for an yearly stipend to be paid her in Calvert County where her abode is Whereupon itt is ordered by the Court here this day to witt the Seventh day of March in the fourth yeare of the Dominion of Charles Lord Baltemore &c Annog Doni 1678 that att the next County Court to be held in Calvert County, There be such care taken by the Comission¹⁵ of the said Court of the said Elizabeth, that she may have a yearly pension for her maintenance, to be paid unto her by the said County, to be raised att the laying of every County Levy.
