 Sum^{oned} to Answer unto James Wasse of a plea
 that he render unto him the sum^e of Seven thousand pounds of
 tobacco which to him he oweth & unjustly detaineth

And whereupon the said James Wasse by Robert Carvile his Attorney saith, that whereas the said W^m Hemsley the second day of february Anno Doni 167⁸ by his certaine writeing Obligatory Sealed with the Seale of him the said W^m Hemsley & here in Court produced whose date is the same day & yeare above written, did acknowledge himselfe to owe & stand indebted & firmly bound unto the said James Wasse Chirurgion of London then in the abovesaid County & Province in the full Sum^e of Seven thousand pounds of good sound M^rchantable tobacco & cask to be paid unto the said James Wasse his heyres or assignes att some convenient place in Talbot County To w^{ch} payment well & truely to be made he did binde himselfe his heyres Ex^{ts} by those p^rsents Notwithstanding which the said W^m the said sum^e of Seven thousand pounds of tobacco unto him the said James Wasse hath not paid, but the same to pay hitherto hath & still doth altogether deny to the da^mage of him the said James ten Thousand pounds of tobacco & thereupon he bringeth his suite.

And the said W^m Hemsley by Kenelm Cheseldyn his Attorney doth come & defend the force & injury when &c and prayeth the hearing of the said writeing & itt is read unto him, he prayeth also the hearing of the Condi^{cion} of the said writeing & itt is read unto him in these words The Condi^{cion} of this Obligac^{ion} is such, that if the above bound W^m Hemsley his heyres Exec^{ts} Adm^{ts} or assignes doe well & truely pay or cause to be paid unto Thomas Tailor of Kings Creek or John Stanley or either of them or their assignes for the use of the abovesaid James Wasse the full sum^e of three Thousand five hundred pounds of sound & bright M^rchantable tobacco & cask picked & culled from ground & under leaves seconds & trash att his own Plantac^{ion} att or upon the tenth of the month October next
