Resolved that the said Christopher Richmond be allowed One hundred Dollars per Month during the time he shall be engaged in the service aforesaid.

Mr. Jubb Fowler is hereby authorized and directed to keep in his possession, the Key of the Stairs leading to the Gallery of the Dome, and to suffer no person to mount them without being attended by himself or some person on whom he can depend to prevent damage to the Stairs or Gallery.
