By this Act, that Part of the Province of *Maryland*, on the West-Side of the Bay of *Chesapeake*, over against the *Isle of Kent*, formerly called by the Name of *Providence*, by the Inhabitants there residing, &c. shall from henceforth be erected into a Shire or County, by the Name of *Ann-Arundel County*, and by that Name to be ever hereafter called.
