N. B. By this Act, a Sum not exceeding 2562 l. 10 s. was Granted for the inlisting, &c. of a

Number, not exceeding 500 Volunteers, to serve in the intended Expedition against the Spanish West-Indies. And Commissioners, viz. One in each County, were appointed and impowered to receive the said Sum out of the Loan-Office, &c. Which Money was to be replaced and repaid

into the Office by a public Assessment in the Years 1741 and 1742, &c.
