By this Act, a Sum not exceeding £. 5000 was Granted for the buying, finding, and providing Victuals, Transports, and other Necessaries, for the 500 Men to be raised in this Province, for his Majesty's Service, for the Expedition against the Territories of the Catholic King in the West-Indies: For the Inlisting of which, Provision had been made by an Act passed the preceding Session, viz. 1740, ch. 1. The Honble Benjamin Tasker, Esq. Col. King, and Doctor Carroll, were appointed Agents for carrying this Act into Execution, and impowered to receive the faid Sum out of the Loan Office, &c. and for the Replacing and Repayment of the same into the Office, one Moiety of all the Duties on Rum, Spirits, Wine and Brandy, Irish Servants and Negroes imported, (which were by any former Acts applied for defraying the Public Charge) was appropriated, together with a Duty upon Ordinary Licences, until the faid Sum of £. 5000, &c. should be fully paid and replaced, &c.
