On Petition of fundry Inhabitants of Prince George's County, Two Years, from the End of this Session, is granted to any Persons, their Heirs or Assigns, who took up any Lots in Bladensburgh, more than was given by the Original Act, to compleat their Buildings. (2.) The Takers-up of Lots, their Heirs or Assigns, on Building one good and substantial Ware-house, which shall cover 400 square Feet of Ground, shall be invested with an Estate in Fee-simple, in such Lot or Lots, although the same hath no Stone or Brick Chimneys.
