

C H A P. XVIII.

An Act for the Relief of Philip Cazeau, a languishing Prisoner in Cæcil County Goal. Lib. B.L.C. fol. 499. PR. Passed 2^d June 1750.

C H A P. XIX.

An Act to enable the Rector and Vestry-men of Great-Choptank Parish, in Dorchester County, to Lease some Land belonging to the said Parish, unimproved. Lib. B.L.C. fol. 500. Ditto.

N. B. By this Act the Rector and Vestry-men are impowered to Lease, Demise, and to Farm Let, any Part or Quantity of Land reserved for the Use of the Parish Church, in the Town of Cambridge, unimproved, not exceeding One Acre and an Half, by Deed Indented under the Hands and Seals of the said Rector and Vestry-men, for the Time being, or the major Part of them, &c. for any Term, not exceeding Twenty-one Years, or Three Lives; and also, on the Expiration of the said Term, to grant new Leases for the Premises for the like Term: The yearly Rents, &c. of the said Land to belong, and be applied to the Use and Benefit of the Rector, for the Time being, and to no other Use. And in all such Leases, a Clause to be inserted, obliging the Lessees to build a Brick or Stone Chimney to every of the Buildings erected on the said Land, where Fire is to be used; and that no Fire shall be made or kept in any wooden Chimneys, on any Part of the Premises, otherwise the Leases to be void.

C H A P. XX.

C H A P. XXI.

An Act to enable the Justices of Frederick County, to levy a ° Sum of Money on the Taxable Inhabitants of ^p All-Faith's Parish in the said County; and for the building a ^q Chapel of Ease in King and Queen Parish, in St. Mary's County; and for other Purposes therein mentioned. Lib. B.L.C. fol. 501. Ditto.

C H A P. XXIII.

An Act impowering the Rector, Vestry-men and Church-wardens of Queen-Caroline Parish, in Anne-Arundel County, for the Time being, to purchase One Acre of Land, and thereon to build a Chapel of Ease in the said Parish; and to empower the Justices of the said County, to levy on the Taxable Inhabitants of the said Parish, the Sum of Twelve Pence Current Money, Yearly, by three annual Assessments, for the Uses therein mentioned. C H A P. XXIV.

WHEREAS it is Enacted by the above recited Act, " That when- Preamble.

" to take up such Horse, Mare, or Gelding, so trespassing, and the same to
