

At a Session of ASSEMBLY begun and held at the City of *Annapolis*, on Wednesday the 28th Day of *September*, and ended the 16th Day of *December*, in the 7th Year of the Dominion of the Right Honourable FREDERICK, absolute Lord and Proprietary of the Provinces of *Maryland* and *Avalon*, Lord Baron of *Baltimore*, &c. *Annoq; Domini*, 1757: The following Laws were Enacted.
