WHEREAS an Act of Assembly of this Province, made at a Session of Assembly, begun and held at the City of Annapolis, on the Second Day of October, One Thousand Seven Hundred and Fifty-three, entitled, *An Act to prevent Masters of Ships, and Vessels, from clandestinely carrying Servants and Slaves, or Persons Indebted, out of this Province,* hath since, by Experience, appeared to be a good and wholesome Law, and very beneficial to the People of this Province: Preamble.

C H A P. XIII.

WHEREAS it hath been found by Experience, That the Setting up Parol Gifts of Negroes, and other Slaves, where the Donor hath retained the Possession and Use, is productive of Disputes and Law Suits, and hath a tendency to introduce Corruption and Perjury, and that such Gifts have been often established upon very slight and suspicious Testimony; For Remedy thereof, Preamble.
