

“ Husband, or through Fear of his Displeasure?” And that, upon such Examination, she shall own the said Acknowledgment to be free and voluntary. And that the Person or Persons so examining her, shall, in the Note or Certificate of the Caption of the said Acknowledgment, certify such her Examination and Acknowledgment thereupon. And that such Certificate be likewise enrolled upon Record. In which case only every such *Femme Covert* shall be barred, and not otherwise; any Thing herein before contained to the contrary notwithstanding.

VI. **Provided** also, That no such Writing indented, shall be at any Time enrolled within this Province, before the Receiver-General of the Lord Proprietary of this Province for the Time being, or the Deputy or Deputies of such Receiver-General for the Time being, shall set his or their *Recepimus* thereunto, if any Fine for Alienation for the said Land be due, and by the original Grant reserved; any Thing to the contrary hereof, in this Act, notwithstanding.
