CHRIST-CHURCH Parish, in Queen Anne's County;—the Parish Church Enlarged, 1748, ch. 8.

Clajon, William, and Mary his Wife, enabled to sell a Lot and Three Dwelling-houses in Annapolis, for Payment of the Debts of Gamaliel Butler, her former Husband, 1762, ch. 30.

Denwood, Levin. See *Groome Samuel, Junior.*

Devegh, Elizabeth. *Her last Will confirmed, and an Estate in Fee Simple in all the Lands, &c. whereof she died seized, vested in her Son John Devegh,* 1718, ch. 14.

Digges, John. *His Copper-Works encouraged,* 1742, ch. 20.

Dixon, William. *His Last Will confirmed,* 1710, ch. 12.

Dorsey, Caleb. *Enabled to sell 49 Acres of Land, the Estate of Mary and Elizabeth Woodward, Infants,* 1742, ch. 17.

Dorsey, Richard. *Enabled to do the same,* 1744, ch. 8.

Dorsey, Edward. *A Fine imposed upon him, and also on the Sheriff's of Cæcil and Talbot Counties,* 1699, ch. 45.

Dorsey, Edward, (Col.) Enabled to sell Entailed Lands and Houses in Annapolis, 1704, ch. 84.

Douglafs, Archibald. *Vested in a Fee Simple Estate in one Moiety of the Level, alias Scutt's Level,* 1741, ch. 9.

Dunbar, John. *Act to Record a Deed to him from James Connel, and Anne his Wife,* 1745, ch. 8.

DURHAM Parish, in Charles County. *A new Church to be built,* 1732, ch. 28; and 1736, ch. 12. *The Vestry enabled to sell certain Church-Lands, and to purchase a new Glebe,* 1751, ch. 6.

Duvall, Benjamin. *Enabled to sell Part of Howerton's Range, and to Entail other Lands in Lieu thereof,* 1720, ch. 5.
