7^{thly} And also in that Execution upon that Scire facias is Awarded against the said Magdalen Administratrix of the said James the heir of the said John for the debt and costs and Additionall Costs Acrueing upon that Scire fac⁸ to be Leavyd of the goods etc. of the said James.

And thereupon the said Jacob and Magdalen pray the Writt of the Lady the Queen to warn the said Hugh Hall Adm^r as aforesaid to be before the Honoble President and Councill Aforesaid to hear the Errors upon the Record and Process aforesaid
