MARYLAND SS Thomas Cockshutt late of Calvert County Clerk als dict Thomas Cockshutt was Summonsed to Answer unto his Laship the Rt Honble the La Propry of a plea that he render unto him five hundred pounds Sterling which to him he Oweth and unjustly detaineth etc.

[442] And Whereupon Thomas Bordley Esq^r Attorney Genth who for his Lordship Prosecuteth Saith that whereas the afs^d Thomas Cockshutt the Nineth day of May in the year of our Lord God Seventeen hundred and Eighteen at Ann arundell County by his Certaine writeing Obligatory did acknowledge himself to be holden and firmly bound to his said L^dship in the afs^d five hundred pounds Sterling to be paid to his said L^dship when afterwards he should be thereunto required Nevertheless the afs^d Thomas Cockshutt altho' offten required the afs^d five hundred pounds Sterling to the said Lord Proprietor hath not rendered but the same to him to Render hath refused and still doth refuse to the Damage of the said L^d Proprietor one thousand pounds Sterling mony afs^d and this the said Thomas Bordley for the said L^d Prop^ry is ready to verifie etc: and he brings here into Court the writeing Obligatory afs^d which testifieth the Debt afs^d in form afs^d whose date is the day and year abovesaid.

The Condition of the above Obligation is such that if the above bound Thomas Lingham [sic] Ex^r of all and Singular the goods Chattles and Creditts of Edward Boteler late of Calver County Deced do make or cause to be made a true and Perfect Inventory of all and Singular the goods Chattles and Creditts of the said Deced appraised in Money and the same so made do exhibitt or Cause to be exhibitted into the Office for probat of Wills etc: at or before the Ninth day of Aug^t now next Ensueing and the said Goods Chattles and Credits do well and truely Administer Viz^t do pay the Debts of the said Deced which he did Owe at the time of his Decease so farr forth as the said goods
