MARYLAND ss^t Charles Absolute Lord and Propry of the Provinces of Maryland and Avalon Lord Baron of Baltemore etc: To the sherriff of Annarundell County Greeting We Command you that you attach any the Goods Chattles rights or Creditts which were of Jonathan Forward late of the City of London Merch^t als dict Jonathan Forward of Annarundell County Merch^t if they shall be found in your Baylywick to the value of Six hundred pounds Sterling and thirty thousand pounds of Tobacco and when you have the same so attached or any part thereof the same in your Custody safe keep so that you have the same before the Justices of our Provinciall Court to be held at Annapolis the first tuesday of April next to Satisfie unto Gilber
