The Condition of the above Obligation is Such that Whereas the above bounden Thomas Gassaway high Sheriff of Annarundell County hath deputed and appointed the above named John Gresham his under Sheriff of and within the County af^s which Said John Gresham hath taken upon him the [591] Burthen of Executing the Said Office and hath well and Sufficiently Secured the Said Thomas Gassaway from all and all manner of Damages which may any wise Accrue to the Said Thomas Gassaway his Ex^{rs} or Adm^{rs} by the Said John Greshams Misfeazance or Negligence therein Now if So be the Said Thomas Gassaway his Ex^{rs} or Adm^{rs} Shall at all or any time or times hereafter upon the reasonable request of the Said John Gresham Assign and Set Over unto the Said John Gresham his Ex^{rs} Adm^{rs} or Assigns by proper Instruments Under the hand or hands of the Said Thomas Gassaway his Ex^{rs} or Adm^{rs} all Such publick and County Allowances which are usually allowed to the Sheriff of the Said County for Collecting and paying the Publick and County Levys and all other Fees profitts and Rewards belonging or in any wise appertaining to the Sheriffs of the Said County and all Prison fees and Accounts and ballances of Accounts that Shall and may at any time appear to be due in respect of his Said office without fraud or delay then this present Obligation to be Void or Otherwise to Stand and remain in full force and Vertue.

Which being read and heard the Said Thomas Gassaway by his Attorney aforesaid prays leave to imparle hereunto untill next Court and he hath it and the Same day is given to the Defendant also

At which Said next Court To witt the fifteenth day of July Anno Dom 1718 Comes again the Said parties plaintiffs and Defendant by their Attorneys aforesaid and the Said Defendant by his Said Attorney prays further Leave to Imparle hereunto Untill Next Court and he hath it and the Same day is given to the plaintiff also.

At which Said next Court To Witt the 16th Day of September Anno Dom Dom 1718 Come again the Said parties Plaintiff and Defendant by their Attorneys aforesaid and the Said Defendant by his Said Attorney as before Defends the force and Injury when etc. And Saith that the Said John his Action aforesaid Against him to have Ought not because he Saith That he the Said Thomas Gassaway from the time of the Making of the Writeing Obligatory aforesaid at all times hitherto upon the reasonable request of the Said John Gresham hath assigned and Set Over unto the Said John Gresham his Ex^{rs} Adm^{rs} or Assigns by proper Instruments under the hand of him the Said Thomas Gassaway all Such publick and County Allowances as were usually allowed to the Sheriff of the Said County for Collecting and paying the Publick and County Levys and all other fees profitts and rewards belonging or anywise appertaining to the Sheriff of the Said County and all prison fees and Accounts and Ballance of Accounts that hath at any time appeared to be due to the Said Thomas Gassaway in respect of his Said office
