Mem^d The plf^t Sued out his Lordships writt of Attachment the Tenour of which follows in these words Viz^t

MARYLAND SS. Charles Absolute Lord and propry of the provinces of Maryland and Avalon Lord Baron of Baltemore etc. To the Sher of Annarundell County Greeting we Command you that you Attach any the Goods Chattles Rights or Creditts which were of Jonathan Forward of Annarundell County Merchant if they Shall be found in your Bailywick to the Value of Six hundred pounds Ster^t and Thirty Thousand Pounds of Tobacco and when you have the Same So Attached or any part thereof the Same in your Custody Safe keep So that you have the Same before the Justices of our Provinciall Court to be held at Annapolis the first Tuesday of April Next to Satisfye unto Gilbert Powlson Mariner as well the Sum of Six hundred Pounds Ster^l and Six Thousand four hundred and fifty one Pounds of Tobacco Certain Damages by the Said Gilbert Powlson recovered Against him before the Justices of our Said Court on the 20th day of September last as the
