Thereupon Afterw^{ds} in the Same Court or Term Mary Hemsley of the City of Annapolis Widdow and Thomas Cockey Patrick Sympson and James Govane of Ann¹ County Merch^{ts} Come into Court and Acknowledge themselves to Owe and Justly indebted unto the Said Gilbert Powlson in the Sume of Twelve hundred Pounds Ster¹ and Sixty Thousand Pounds of Tobacco to be Levyed on their body Goods or Chattles Lands or Tenements to the use of the Said Gilbert Powlson According to Law. In Case the Said Jonathan Forward does not prosecute the Said Appeale with Effect According to Act of Assembly in that Case made and provided.
