The Court Adjourns Untill to Morning [sic] 9 of the Clock before Noon Wednesday July the 15<sup>th</sup> 1724 The Court meet According to adjournment Present: His Honour the Governour; Coł Sam<sup>t</sup> young; John Hall Esq<sup>r</sup>; Coł Richard Tilghman; Coł. M: Tilghman Ward; Benj<sup>a</sup> Tasker Esq<sup>r</sup>. Esq<sup>r</sup> Loyd thereafter Came and took his Seat.

Ruled this day that for the future that in all Writts of Error and Appeals to be brought into this Court that the Errors to be filed thereon be filed in forty days after the End of Each Appearance Court or that the said Appeals or Writts of Error for Default thereof Should (as by the former rules of this Court) Abate.
