

3 That Sometime after the Complainant had Commenced his action at Law ag<sup>t</sup> the Defend<sup>t</sup> Brewerton the Compl<sup>t</sup> and Tho<sup>s</sup> Dashiell the Sherriff of Somerset County Came to the Deponent and persuaded the Deponent and Sam<sup>l</sup> Alexander to go with them in the Night to the Defendant Brewertons and that as they were going to the Said Brewertons they met the Defend<sup>t</sup> Adams who Stopt the Said Dashiell to talk with him and the rest of the Company rode on but that the S<sup>d</sup> Dashiell Soon overtook them and desired the Compl<sup>t</sup> and Sam<sup>l</sup> Alexander to ride on to the Said Brewertons as fast as they Could for he was afraid the def<sup>t</sup> Adams would give the Def<sup>t</sup> Brewerton Notice that he was going there before he the S<sup>d</sup> Dashiell could get there himself This Deponent further Sayth that the Said Compl<sup>t</sup> and Samuel Alexander and Samuel Alexander [sic] did ride on and that the Said Dashiell and the Deponent followed they and that when they the Said Dashiell and the Deponent got to Brewertons they found the Same horse which the Def<sup>t</sup> Adams had with him when they left him tyed to the fence and Soon afterwards the Said Adams came up on foot and told the Deponent that he came to his Plantation and found the Doors of the hinges and was Come over there to See if any of the people had lived at his S<sup>d</sup> Plantation were there and that he had left his horse under a peache tree tyed altho the S<sup>d</sup> Horse then Stood tyed by the Depon<sup>t</sup> the Depon<sup>t</sup> further Saith that he hath often before the Action brought by the Compl<sup>t</sup> ag<sup>t</sup> the Def<sup>t</sup> Brewerton heard the Said Brewerton Say that the Compl<sup>t</sup> was to have part of his Land next to Cronches Plantation and further Saith not

[762] Isaac Noble of Stepney Parish in Somerset County Aged about 43 years being Sworne and Examined on the Part of the Complaint Saith as follows Viz<sup>t</sup>

1 That he well knows the parties the Complainant and the Def<sup>t</sup>.

2 That in the year 1718 the Def<sup>t</sup> Brewerton was indebted to the Complainant in about Seven Thousand Pounds of Tob<sup>o</sup> w<sup>ch</sup> this Depon<sup>t</sup> beleives was for Tob<sup>o</sup> w<sup>ch</sup> the Compl<sup>t</sup> had paid for the S<sup>d</sup> Brewerton for that this Depon<sup>t</sup> hath Carried Severall Notes between them This Depon<sup>t</sup> further Saith That Tob<sup>o</sup> was at the Time of the Debts becoming Due to the Compl<sup>t</sup> worth Twenty or Twenty five Shi<sup>ll</sup> Per hundred and that he beleives that the Def<sup>t</sup> Adams Purchasing a part of Brewertons Land was the reason that the Def<sup>t</sup> Brewerton Did not Satisfie the Compl<sup>t</sup> before he Sued him for it and further Saith not.

2 That the Def<sup>t</sup> Brewerton in the year 1718 when Tob<sup>o</sup> was worth Twenty or Twenty five Shi<sup>ll</sup> Per hundred became indebted to the Compl<sup>t</sup>
