William Alexander of Stepney Parish in Somersett County Planter Aged 50 years or thereabouts Sworn and Examined on the part of the Complainant Saith as follows Viz^t.

That at the request of the Compl^t the Dep^t went with the Compl^t to the Plantation of W^m Brewerton and that the S^d Brewerton went with them and the Marked a tree for a Corner tree of the Land w^{ch} the Compl^t was to have of him the S^d Brewerton near the Wading Place from whence they run out a p^s. [sic] of a Line but were prevented from proceeding any further by Night Coming on he further Saith that he hath often heard the Def^t Brewerton Say that no other person in Maryland Should have his Land but the Compl^t and further Saith not.

That W^m Brewerton the Def^t hath often told the Depon^t that the Second Conveyance to the Def^t Adams was for to deprive the Compl^t from being benefitted by his Execution and that the Def^t Adams was to reconvey it and that he hath heard the Said Adams Say he would reconvey it when Captⁿ John Jones and John Roach Should Value Sixty Acres that the Def^t Adams had bought of the S^d Brewerton and further Saith not.

That at the request of the Compl^t he went wth him and W^m Alexander to the House of the Def^t Brewerton and from thence wth Brewerton and the persons af^d went and marked a tree near the old Wading place of Pasandike being Near the S^d Brewertons fence w^{ch} this Depon^t Supposes was Intended to be a Corner Tree of Land disigned by W^m Brewerton to be Sold the Compl^t and from thence they run p^s of a Line and resolved to make an end Some time afterw^d This Depon^t further Saith that the Compl^t Desired the trees might be markt as they run but Brewerton was not willing to have it Done till he Saw how the Line would run
