Whereupon the said Tho^s Nelson lessee of the said John Diggs by his attorney afores^d Prays an Appeale from the Judgment of this Court So as afs^d Rendered Ag^t him to the High Court of Appeales of this Province which is Granted Upon Giving Security for the Due Prosecution thereof According to Law.

Whereupon afterwards in the [794] Same Court or Terme the Said Tho^s Nelson Lessee of the said John Diggs together with Charles Carroll and Joshua George His Sureties Enter into the following Bond for the Due prosecution of the Appeale afs^d According to Law Viz:

MARYLAND SS: Know all men by these Presents That we John Digges of Prince Georges Gen^t and Doctor Charles Carroll of Ann Arund^l County Gen^t and Joshua George of Cecil County att^{ry} at Law are Held and firmly bound unto Jn^o Beale of Charles County in the full and just Sum of twenty thousand pounds of Tobacco to be paid unto the said John Beale his Certain Ex^{rs} adm^{rs} or assigns To which payment well and truly to be made and Done We bind Us and Every of Us Our and Every of our Heirs Ex^{rs} and Adm^{rs} joyntly and and [sic] Severally for the whole and in the firmly by these presents Sealed with our Seals and Dated this 24th Day of October 1726.

The Condition of the above obligation is Such that if Thomas Nelson Lessee of the above said John Diggs shall prosecute with Effect an Appeale Entered to be brought before his Honour the Governour and his Lordships Hon^{ble} Council in the High Court of Appeals and Errors within the province afs^d from a Judgment obtained by the afores^d John Beale against the said Thomas Nelson Lessee afs^d before the justices of the Provinciaall Court And also Satisfie and pay unto the said John Beale all and Singular the Costs and Damages that have been adjudged in the Said Provinciaall Court and shall be Awarded by the Governour and Council afores^d in the said Court of Appeales and Errors to be paid to the said John Beale by the said Thomas Nelson Lessee afores^d in Case the judgment afs^d in the Provinciaall Court be affirmed. Then this obligation to be Void Else to Stand and remain in full force and virtue in Law.
