[129] And whereupon the Said Clement Sale by Robert Gouldsborough his Attorney Saith That whereas the Said John Salter the 22th day of September Annoque Dni 1697 att York Town in Talbott County by his Certain Bill or Writing Obligatory Sealed with his Seale as his Act and Deed delivered and hereinto Court brought whose Date is the Same day and Year, he bound
