Southern County: Coll^r W^m: Coulbourne of this County was summoned to appear before King of the County in
 manner of a Justice of the Peace to prosecute John de & Richard de ...
 And whereupon said Alexander by Thomas Pooler his attorney Complaineth that whereas it is set out in
 27th day of December in the first year of the Dominion of King Charles over Maryland by Anne, Do^{tr}
 1675. Did by his certain writing under his hand & Seal constitute & appointe a pl^t: Deputie Sheriff to
 serve in the name of process which to him is set out: then high Sheriff of this County should be long to serve
 till the last of March then next following which writing is here in coll^r produced in pl^t: accepting of his office
 the said coll^r: Coulbourne did assume upon himself a promise to pay unto pl^t: ^{one half} of the fees due upon all
 manner of writs &c by a pl^t: executed the which in all did amount to a sum or quantity of two thousand
 one hundred & eightie five pounds of Tobacco as was here in coll^r produced with appearance whereof due to a pl^t
 from a debt one thousand eightie two pounds of Tobacco & a pound of Tobacco notwithstanding his promise
 to pay in same refused & still doth refuse to pay a pl^t: a sum of Tobacco to a pl^t: damage two thousand
 pounds of Tobacco & thereupon brings this suit: 1. 1/2 Queo Tho: Pooler: 1.

And the sd Coll^r: W^m: Coulbourne by Thomas Jones his attorney Cometh & defendeth in law & Injurie when
 it saith hee is not guilty & thereupon hee the Declaration not amounting to sum: 1. This following
