Tobacco money due and to be due upon bill of exchange and all other demands whatsoever -
as now are or hereafter shall be due payable or belonging or to be delivered unto us or any of us by
or from any person or persons whatsoever in Maryland or else where in America And for
default of payment or delivery of any Summe of money parcell or parcelles of Tobacco or other
things to us due or to be due or belonging to us all lawfull wayes & meanes for recovery -
therof by anon sute chrest bill plaint Attachment ^{and otherwise} as fully and ample in every
respect as we our selves might or could doe if wee were personally present & to sue nuphad make
answ^r prosecute & defend in any Court or Courts of Law or Equity and before any Judge or Justices -
in any such matter or Cause with us for us or against us as the Cause shall require & to deal
& intermeddle in all anons Sutes affaires and busineses any waies touching or concerning
us as our Agent or factor or otherwise giving & by these presents granting unto our said
Attorney full & whole & lawfull Authority in the execution of all & singular the Premises
& to substitute & appoynt one or more Attorney or Attorneys in any of y^e premises & the same
again at his pleasure to revoke And to make & give any acquittance release or discharge upon
y^e recovery and receipt of any Debt Summe or Summes of money or other thing whatsoever -
as the Cause shall require And generally to say doe execute compound Conclude agree -
determine & finish all & every other Act and Acts thing & things whatsoever within or about
y^e premises shall be requisite or needfull to be had made or done & that in as large ample
manner and as fully and effectually to all intents & purposes as wee our selves might
ought or could if wee were present in our own ^{proper} persons; ratifying allowing for firm effectuall
and Irrevocable all & whatsoever our said Attorney shall doe or Cause to be don in or about the
Premises by virtue of these presents In witness whereof wee the said James Braime Samuel
Groom the elder And Richard Angell have hereunto sett our hands & seals the seventeenth
